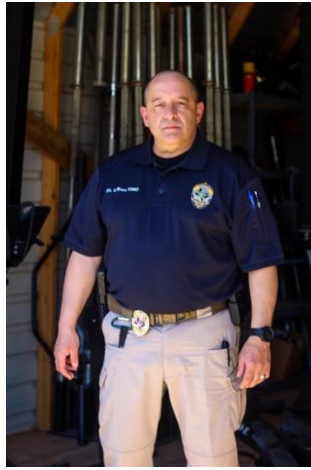

**Instructor:** Omar Rivera

Omar Rivera is currently assigned to the El Paso Police Academy. He holds Basic Instructor Proficiency Certificate as well as a Master Peace Officer Certification. Omar Rivera has a bachelor's degree in Criminal Justice and is currently working on a Master's degree at Howard Payne University in Theology and Ministry.

Omar Rivera began his journey in 1982 as part of the United States Army and completed 20 years of service. Omar Rivera joined the El Paso Police Department in 2007 and has 15 years of experience as a peace officer. Omar was assigned to the Central Regional Command working patrol on graveyard shift for 10 years and trained several officers as he was a Field Training Officer. After Omar left patrol, he worked with the Human Resource Background Investigation Unit for 2 ½ years completing investigative background packets of candidates who were applying for the El Paso Police Department. He assisted with recruiting at job fairs and on Ft. Bliss, Texas and throughout the City of El Paso. Omar then returned to the Central Regional Command as a Community Representative where he worked resolving problems in the community. Omar also worked with different agencies in helping to resolve homelessness due to the Covid pandemic.

Omar Rivera created the Duty to Intervene Course to be taught to the entire El Paso Police Department for quarterly training and has now partnered with Texas Police Trainers LLC to administer this training statewide for the Texas law enforcement community.
