Richard is a certified Texas Master Peace Officer, certified Advanced Law Enforcement Instructor, certified as a police instructor through the Federal Law Enforcement Training Center (FLETC), a certified firearms instructor for police and security officers, a police driving instructor, and is a certified Special Investigator in the State of Texas. Richard earned a Master's Degree in Criminal Justice Leadership and Management with a Bachelor's Degree in Criminal Justice – Human Services; with a specialty in Sociology. He is also a Certified Public Manager (CPM).

During his career, Richard has worked as a patrol officer, campus officer, patrol supervisor, training sergeant, police instructor, field training officer, criminal investigator, law enforcement academy supervisor, academy manager, special agent – superintendent, and protective services operative.
